(In terms of Regulation 36(5) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations")

The Company had appointed M/s. Biju George &Co, Chartered Accountants (Membership No. 206233) as the Statutory Auditors of the Company at the Annual General Meeting ("AGM") held on 29th September, 2014 from the conclusion of the 22nd AGM for the financial year 2014-15 till the conclusion of the 27th AGM.

Further, pursuant to the provisions of Sections 139, 141, 142 and other applicable provisions of the Act read with the Rules made thereunder and the SEBI "Listing Regulations", the Board of Directors of the Company ("Board"), on the recommendation of the Audit Committee, had recommended the appointment of M/s. Maharaj Rajan & Mathew, Chartered Accountants, (Firm Registration No. 01932S) for a period of five consecutive years, to hold office from the conclusion of the Twenty Seventh Annual General Meeting of the Company till the conclusion of Thirty Second Annual



General Meeting of the Company to be held for Financial Year 2023-24 at an annual remuneration for the financial year ending 31st March, 2020 amounting to 1,50,000/- on a consolidated basis plus out of pocket expenses and applicable taxes. There is no material change in the fees for the statutory audit fees paid to M/s. Biju George & Co, Chartered Accountants (Membership No. 206233) for the financial year 2018-19, the retiring Statutory Auditors and the fees proposed to be paid to M/s. Maharaj Rajan & Mathew, Chartered Accountants, (Firm Registration No. 01932S) for the financial year 2019-20.

It is proposed to give authority to the Board, on the recommendation of the Audit Committee, to agree, alter and vary the terms and conditions of such appointment, remuneration etc. and to fix the remuneration to be paid for the subsequent years during their remaining tenure as the Statutory Auditors of the Company including out of pocket expenses and applicable taxes, as mutually agreed with the Statutory Auditors.

M/s. Maharaj Rajan & Mathew is a firm of Chartered Accountants registered with the Institute of Chartered Accountants of India established in the year 1984 with its Registered Office at Ernakulam. It is primarily engaged in providing audit and taxation services to its clients.

The management and the Board had carried out a detailed evaluation process of various audit firms based on which the Board, on the recommendation of the Audit Committee, has recommended the appointment of M/s. In terms of the recently notified SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018, consent of the Members by way of Special Resolution is required for appointment of a Non-Executive Director who is aged above seventy five years. Ms. Shailaja Chandra had to step down from the Board with effect from 16th June,2019 in order that the Company can comply with the criteria of Regulation 17(1A) of SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018. The Board considers that her association would be of immense benefit to the Company and it is desirable to continue to avail her services. Accordingly, the item is placed before the members for their approval.


